Privacy Statement

This privacy notice provides information about the ways in which the W2 Foundation collects, stores, shares or keeps personal information provided by our contact. The W2 Foundation fully respects your right to privacy and actively seeks to preserve the privacy rights of those who share information with us. The W2 Foundation will not collect any personal information about you without your permission save in cases where we are required to do so by law (e.g. the investigation of a criminal offence, breach of policies, procedures or guidelines etc). Any personal information which you volunteer to the W2 Foundation will be treated with the highest standards of security and confidentiality, in accordance with the Data Protection.

Collection of Personal Information

The W2 Foundation does not collect any personal data about you on its website, apart from information which you volunteer (through email, contacting us, donations or subscribing to W2 Foundation events and news). Any information, which you provide in this way, is not made available to any third party unless stated and is used by the W2 Foundation only in line with the purpose for which you provided it. Third Party consent, where necessary will be stated and requested at time of providing information.

Collection for Technical Information

Cookies may be used by the W2 Foundation website to collect non-personal information about how visitors use our website or to remember display preferences. Temporary session cookies may also be used in some areas to enable specific functionality. Session cookies are deleted once you close your browser session.

Occasionally for the purposes of W2 Foundation online services we must pass some cookie information to third parties. These cookies may persist after your browser session has ended. This information will not include any of your personal data or information from which you will be readily identifiable. This information may be used for evaluating your use of the website, compiling reports on website activity for W2 Foundation and providing other services relating to website activity and internet usage. It is stored and used in the aggregate only and is not used to obtain personal data or to contact you personally, but instead to improve website services. The W2 Foundation actively seeks to preserve user privacy in any interaction with third parties.

Some areas within the W2 Foundation website use online data entry forms to collect personal information from web visitors who choose to identify themselves for the purpose of receiving products, services, or information. Areas within our websites that collect data of any type are required to abide by our Privacy Statement. We request no more information than is required to fulfil the purpose for which the information is being collected.

Technical details in connection with visits to our websites may be logged by W2 Foundation internet service provider for accounting and auditing purposes. This technical information will be used only for statistical and other administrative purposes. You should note that technical details, which the W2 Foundation cannot associate with any identifiable individual, do not constitute `personal data' for the purposes of the Data Protection Act 1988 and Data Protection (Amendment) Act 2003.

Rights of Access, Rectification and Erasure

You have a right to be given a copy of personal data held about you. You also have the right to have your data corrected, if inaccurate, or erased, if the W2 Foundation does not have a legitimate reason for retaining the data.
